## Technical Regulation on standard times for certain statutory surveys of fishing vessels

The following is laid down pursuant to sections 3, 17(2) and (5) and section 24(1) and (5) of the Act on safety at sea, cf. Consolidated Act No. 627 of 26 July 2002, as amended by Act No 1173 of 19 December 2003 and Act No 1231 of 27 December 2003 and following authorisation from the Danish Minister for Economic and Business Affairs:

**Section 1**. Standard times are employed in the case of the following statutory surveys carried out by the Danish Maritime Authority:

- 1) Initial survey of new buildings, major alterations and purchased fishing vessels.
- 2) Renewal survey and intermediate survey of fishing vessels.

Subsection 2. The standard time is defined as the time, within normal working hours, that the Danish Maritime Authority makes available, free of charge, to the shipyard, ship owner and the ship's master for conducting a statutory survey.

Subsection 3. Included in the standard time is the time spent by the Danish Maritime Authority on file handling, design approval, other preparations for the survey and producing reports on conclusion of the survey. In addition, a limited amount of time is included for providing guidance for the shipyard, the vessel's officers and crew concerning regulations in force and any future regulations of importance for the vessel.

Subsection 4. Travel time in connection with a survey is not included in the standard time.

**Section 2.** Payment is only collected for exceeding the standard time for a particular survey where it is exceeded by more than 1 hour, but in such a way that in a given case the first hour that the standard time is exceeded is also paid for.

Subsection 2. Payment shall be made in accordance with the Danish Maritime Authority's Order on payment for the survey of ships etc.<sup>1))</sup>

**Section 3**. The standard times are printed as an annex to this Regulation.

Section 4. This Regulation shall enter into force on 1 January 2005.

Subsection 2. Technical Regulation No 10 of 28 November 2002 on standard times for certain statutory surveys of fishing vessels shall be rescinded.

Subsection 3. This Regulation shall not apply to surveys conducted in Greenland.
