# Order on the payment for the survey of ships, etc., in Greenland

Pursuant to Sections 17(6) and 24(1)(2) and (4) of the Act on Safety at Sea, cf. Consolidation Act no. 221 of 11 February 2022, and Sections 17(5) and 24(1),(2) and (4) of the Order on the entry into force for Greenland of the Act on Safety at Sea, cf. Order no. 1674 of 16 December 2015, shall be adopted by virtue of the authorisation granted under Section 1(1)(3) of Order no. 261 of 23 March 2020 on the transfer of certain powers to the Danish Maritime Authority and on the right of appeal, etc, and Section 1(1)(2) of Order no. 279 of 23 March 2020 for Greenland on the transfer of certain powers to the Danish Maritime Authority and on the right to appeal, etc.:

**Section 1.** Payment in accordance with the rules laid down by the Ministry of Finance on the price calculation for revenue-generating activities is applied by the Danish Maritime Authority in the following cases:

- 1) In areas where classification societies, other companies or individuals are authorised to carry out inspections, surveys or similar on behalf of the Danish Maritime Authority, but where the Danish Maritime Authority is requested to carry out the work.
- 2) In the case of non-statutory surveys carried out on Danish or foreign ships upon request.
- 3) If a ship on which the Danish Maritime Authority has carried out a first survey in whole or in part before the ship is put into service is, contrary to expectations, not included in one of the Danish registers.

- 4) In the case of a survey conducted by the Danish Maritime Authority, an exemption from the classification requirement has been granted.

**Section 2.** Payment in accordance with the rules laid down by the Ministry of Finance on the price calculation when calculating fees is applied by the Danish Maritime Authority in the following cases:

- 1) For other surveys of fishing vessels, where:
  - a) The Danish Maritime Authority conducts the first survey abroad or in the Faroe Islands before the vessel is put into operation, as well as other surveys conducted abroad or in the Faroe Islands upon request.
  - b) The agreed survey could not be commenced, must be interrupted, or could not be completed within the standard time set by the Minister for Industry, Business and Financial Affairs due to circumstances affecting the shipyard, the shipping company, or its representatives.
- 2) For the Danish Maritime Authority's surveys on vessels other than fishing vessels, which are prescribed pursuant to the law and are not covered by the provisions on income-generating activities.
- 3) When work is carried out in connection with the approval of ship equipment and vessels.
- 4) When a port state control of a foreign or Faroese ship has identified faults that justify detention of the ship.

5) In the event of an unsuccessful departure due to the behaviour of the shipyard, the shipping company or its representatives.

**Section 3.** For surveys abroad and in the Faroe Islands, separate payment is charged for travel and accommodation expenses.

*Subsection 2.* For surveys conducted on ships at sea, a separate payment is charged for transportation costs from land to the ship and back.

*Subsection 3.* If, at the applicant's request, a survey in Greenland is carried out without taking into account the

Danish Maritime Authority's organisation of the Authority's other survey activities in Greenland, the Authority may charge an hourly rate for travel time and payment for travel and accommodation expenses.

**Section 4.** As a condition for the commencement or completion

of a survey, investigation, or similar, the Danish Maritime Authority may require that a deposit be paid or a guarantee be provided.

**Section 5.** In the event of late or non-payment for services covered by this Order, the Danish Maritime Authority may impose a reminder fee of DKK 100 for each reminder issued.

*Subsection 2.* Amounts due may be recovered by distress and may be subject to interest at the interest rate stipulated in the Act on Interest on Late Payment, etc.

**Section 6.** The Danish Maritime Authority charges a fee of DKK 1,880 per hour or part thereof for surveys and case processing in accordance with this Order.

**Section 7.** This Order entered into force on 1 January 2026.

*Subsection 2.* Order no. 738 of 14 July 2005 on payment for inspection of ships, etc., in Greenland is repealed
